Club Financials - 2022 VOA Fiscal Budget - Big Picture

Where are we with Financials in 2022? Are we still in Balance?

- Membership
 - ✓ 1338 members on the portal as of 25 October 2022 = 1306 + 32 (covered members + brought forward)
- > Show me the Money! (currently, \$\$ based on 30 September 2022 and 1299 members)
 - **✓ 2022 Receivables** \$254,376 − in progress
 - ✓ 2022 Payables \$210,520 in progress
 - ✓ Cash Available \$ 43,857 current estimates for closeout on 31 December 2022
- October's big ticket items:
 - ✓ Viper Quarterly Magazine (\$5.5K estimate to print & ship VQM32)
 - ☑ Picking up VOA store items London, Ohio (\$1,650) unplanned expense
 - Store sold just over \$5.4K in goods and services
 - Store cost us just over \$1.5k for shipping and handling fees
 - Store charged us \$1.65K for packing and labor to assist with the loadout of CO team's NVE-5 clothing item pick-up
- Continued transparency in 2022

 - ✓ Showing how we forecast expenditures and pay our bills every month to eliminate surprises.



Club Financials - 2023 VOA Fiscal Collections - Big Picture

Where are we with Membership and the Financials for 2023?

Membership

- ✓ 351 members on the portal as of 25 October 2022 = 327 + 24 (covered members)
 - √ 40 paid VOA Members 12%
 - ✓ 287 paid Mamba Member 88%
- Show me the Money! (currently a mix-bag, \$\$ for 2022 membership mixed in with 2023 membership renewals)
 - √ 2023 Receivables \$ 62,970
 - ✓ 2023 Payables \$ 17,985 for Regional Payment distribution at \$65/member
 - ✓ Cash Available \$44,985 current National 2023 Account Balance for operations estimate

Continued transparency in 2023

- ✓ This slide does not provide the 2023 VOA National budget
- ✓ This slide provides a very simplified look of collections vs regional payments
- ✓ January BoD meeting will be the first forecasted budget estimate accounting for all known expenses
