Where are we with 2022 Budget Balance? We are we still in Balance?

- > Membership
 - ✓ Target 1050 members by 28 February 2022 currently at 1085 as of 28 February 2022 w/ 28 pending
 - Regular Membership 335 or 30.9%
 - Mamba Membership 750 or 69.1%
- Show me the Money!
 - ✓ 2022 Receivables \$202,871
 - ✓ 2022 Payables <u>\$187,865</u>
 - ✓ Cash Available \$ 15,006

February's big ticket items:

- ☑ Membership Packages and Cards \$13.6K
- ☑ Viper Quarterly Magazine \$ TBD (initial estimate was \$7.5K edit & design with \$6.1K to print & ship VQM30)
- **VOA** Insurance Policy \$ 5.0K will become about a \$1.6K monthly expense after initial payment
- ☑ Wilson bill was right in alignment with estimates
- What was a surprise this month unplanned expense:
 - ACH Fees \$25 per account x 2 accounts x 12 months = \$575 (saves about \$1300 in just Regional split disbursements)
